Describe your goals if you are elected to the above position. One goal is to raise awareness of the need to maintain our profession as a profession and the importance of our profession in society (see below). Another is to raise awareness among DRI members of the importance of being a member, as well as benefits brought through membership. As an organization, we must be at the forefront of being relevant to our members, (bringing value to our members). As such, another goal would be working with our organization to maintain relevance on all fronts with our members. As the practice changes with technology, and our profession as a profession is attacked, we need to be on the forefront of addressing these issues to benefit our members, to advise our membership of the issues facing our profession, and to be on the front line protecting our profession.

What do you believe is the most important issue confronting the defense bar?

Although there are many issues confronting the bar, the most important is the loss of the legal profession as a profession. The practice of law has become more and more of a business, with lawyers losing sight of the practice as a profession. With the focus of the practice becoming the bottom line, resulting in cuts of expenses (organization dues), law firms and lawyers are increasingly losing sight of their role as professionals, including preserving the civil justice system for all citizens, providing the best training to our associates so as to assure the next generation of well-trained lawyers, and meeting the high professional and ethical standards that our profession requires. We are being faced with the prospect of corporations owning law firms (and litigation funding), focusing even more on the bottom line and less on achieving the best result for our clients honestly, ethically, and economically. We are faced with online legal providers, "non-lawyer consumer-facing legal services" and online dispute resolution. Losing our profession, as a profession, results in a loss in confidence of the public in our profession, resulting in a negative view of lawyers in general and a distrust in the profession. And because of the focus on the bottom line, lawyers are becoming increasingly apathetic to the issues facing (and attacking) the profession.

Define the appropriate role for DRI as the national defense bar organization.

DRI must be at the forefront on national issues facing the defense bar and our chosen profession. DRI is the largest national defense organization with a substantial network of defense leaders across the country, with the ability to sufficiently and efficiently address issues and create policy affecting the defense bar, and to protect the defense bar, its clients and the citizens from attacks on our civil justice

system. The DRI's Center for Law and Public Policy brings home this position and offers a platform to be the national leader on such issues, and to provide assistance and coordination to SLDO's to address these issues. DRI must continue to act as the leading provider of quality education and training of defense lawyers (with increased focus on technological changes to the practice), and should continue to work toward a national coordinated effort with all SLDO's on issues of both local and national importance affecting our profession and the civil justice system.

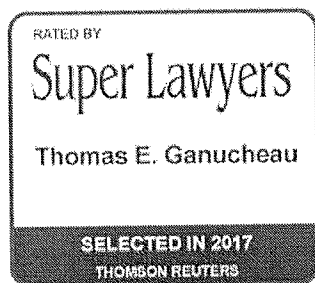

Professional Liability
