



The Hack of a Century and the Fallout: From Wall Street to Main Street and from Capitol Hill to Your Town Hall

The ongoing SolarWinds cyberattack, America's "Cyber Pearl Harbor," is a painful reminder of the vulnerability of government, academia, for-profit corporations, and non-profit organizations to nation state cyberattacks. Nation state cyberattacks against public and private sector organizations of all sizes are increasing in volume, sophistication, effectiveness, and covertness. This panel will first address the serious risks that nation state cyberattacks pose to our lives, liberty, and security. Next, the panel will provide recommendations on critical steps public and private sector organizations can take to help protect themselves and others against nation state (and other) cyberattacks—from implementing specific cybersecurity measures to coordinating, cooperating, and sharing information with other public and private sector organizations. From Advocate to Advisor: Ethical Considerations for Attorneys in Early Case Resolutions

Communication and Resolution Programs (CRPs) are an emerging form of conflict resolution in healthcare intended to settle claims of medical negligence without resorting to litigation. CRPs have produced compelling evidence thus far that seems to support an ethical and business case for proactively disclosing medical negligence, mediating disputes after unexpected patient injuries, and making early offers of fair compensation when patients are harmed by preventable mistakes. While these programs are currently most common in the healthcare setting, they could be used broadly in many other contexts as well. This session will cover ethical considerations for attorneys advising clients on how to conduct difficult conversations with potential claimants.


KEYNOTE: Presidential Chat with IBRAM X. KENDI

He is a National Book Award-winning and #1 New York Times bestselling author of four books. Dr. Kendi is the Andrew W. Mellon Professor in the Humanities and the Founding Director of the Boston University Center for Antiracist Research. He is also the 2020–2021 Frances B. Cashin Fellow at the Radcliffe Institute for Advanced Study at Harvard University. Dr. Kendi is a contributing writer at the Atlantic and a CBS News Racial Justice Contributor. He is the host of Be Antiracist with Ibram X. Kendi, launched a new podcast in June 2021 with Pushkin Industries and iHeartMedia. In 2020, Time magazine named him one of

the 100 most influential people in the world.



Dr. Kendi is also the author of four #1 New York Times bestsellers. How to Be an Antiracist, an international bestseller that has been translated in several languages. It made several Best Books of 2019 lists and was described in the New York Times as "the most courageous book to date on the problem of race in the Western mind." Dr. Kendi has published op-eds in numerous periodicals, including the Atlantic, the New York Times, the Guardian, the Washington Post, London Review, Time, Salon, Diverse: Issues in Higher Education, Paris Review, Black Perspectives, and The Chronicle of Higher Education. He commented on a series of international, national, and local media outlets, such as CNN, ABC, CBS, MSNBC, NPR, Al Jazeerah, PBS, BBC, Democracy Now, OWN, BET, and Sirius XM.

Renée DiResta is the technical research manager at Stanford Internet Observatory, a cross-disciplinary program of research, teaching, and policy engagement for the study of abuse in current information technologies. Renee investigates the spread of narratives across social and media networks, with an interest in understanding how platform algorithms and affordances intersect with user behavior and factional crowd dynamics. She studies how actors leverage the information ecosystem to exert influence, from domestic activists promoting health misinformation and conspiracy theories, to the full-spectrum information operations executed by state actors.

Renée regularly writes and speaks about technology policy, and influence operations. She is an ideas contributor at *Wired* and the *Atlantic*. Her tech industry writing, analysis, talks, and data visualizations have been featured or covered by numerous media outlets, including the *New York Times*, the *Washington Post*, CNN, CNBC, *Bloomberg*, the *Yale Review*, *Fast Company*, *Politico*, *TechCrunch*, *Wired*, *Slate*, *Forbes*, *Buzzfeed*, the *Economist*, the *Journal of Commerce*, and more. She appeared in the documentary *The Social Dilemma*.





Protecting the Independence of the Judiciary


